maCares Paws for a Cause Craft Festival Guidelines

*Please keep a copy of these Guidelines.
Adhering to these Guidelines helps ensure a smooth and fulfilling experience for all.*

- maCares reserves the right to limit the type of vendors and the number of vendors in a particular category.
- maCares may choose to deny the application of a vendor based on appropriateness of products, duplication of vendors or for any other reason. **No reason need be given for a declined application.** Vendors may not bring or sell alcoholic beverages of any kind.
- **Exhibited Items:** All items exhibited and sold at this event must be applicant's original handcrafted work. Only items approved from your application may be displayed and sold. If you display items for which you were not juried, you will be asked to remove those items.
- **Baked Goods/Food Items:** All vendors selling baked or prepared food items are required to prepare foods in a kitchen approved by the NC Department of Agriculture. If your facilities do not meet this requirement, please contact the Festival Director to see if other arrangements for food preparation can be made.
- **Commercial Products:** The direct sale of commercial products is not permitted. Direct sales of handcrafted or commercially made merchandise bought for resale, merchandise sold on a consignment basis, or merchandise sold by a representative are specifically excluded from participation. If your end item contains any type of manufactured items, the end item must be significantly and permanently altered by hand. If you are unsure of your product, please contact the Festival Director for clarification.
- **NC Sales Tax:** If applicable, vendors will be responsible for their own collection and reporting of sales tax to the NC Department of Revenue Sales and Use Tax Division.
- **Booth Spaces:** Booths are on the grounds (mostly in grass) of the church and will run parallel to Guilford Rd. Spaces are 10' x 10' and vendors are required to stay within their assigned spaces. The location of each vendor's space is subject to the discretion of maCares. Vendors are required to have a tent, and it must be securely weighted to the ground. This is an outdoor festival held rain or shine, so prepare accordingly. Vendors are responsible for the set-up and clean-up of their spaces. Each vendor is responsible to bring his/her own tent, tables, table cloths, table skirts, chairs, and supplies. Vendors cannot impair other's spaces (i.e. sign or display blockage). Vendors will not be allowed to move space locations once a space has been assigned. Electricity is not available. Spaces are reserved on a first come, first serve basis. Booths must be manned at all times during festival hours. Vendors must not break down their booths before 4:00 pm.
- **Times:** Set-up is from 8:00 am until 10:00 am on June 8. We ask vendors to drop off their tent and set-up materials in their booth location and then immediately move their vehicle to the rear parking area.
- **Deadline:** Your application must be received by May 3.
- **Acceptance:** Every applicant will receive separate confirmation of acceptance or denial for participation at this event no later than May 17. Booth payment is due by May 24. Final information will be emailed no later than May 31.
- **Refunds:** This event will be held rain or shine. No refunds issued to approved vendors after May 24, 2019.
- **Pets:** Pets are not allowed on the grounds. Registered service animals are allowed and will be onsite.
- **Problems/Issues:** If there are any problems or issues, they should be brought to the attention of the Festival Director. We respectfully request that all applicants refrain from any public remarks or complaints until maCares has had an opportunity to resolve the issue.

WAIVER AND RELEASE OF LIABILITY

For and in consideration of the opportunity to participate in the maCares Craft Festival (the “**Event**”) at First Baptist Church of Jamestown (the “**Facility**”), I, as an individual, sole proprietor and/or on behalf of any associated entity (“**Vendor**”), and on behalf of my personal representatives, executors, administrators, successors, assigns, heirs and next of kin, willingly enter into this Wavier and Release of Liability (“**Agreement**”) and hereby agree to the following:

1. I hereby elect to participate in the Event in order to offer my handmade, homemade and/or homegrown products and/or services for sale as. I am aware that during my participation in the Event certain risks may be present, and that accidents, losses, damages, or personal injuries may occur, and I am voluntarily and without coercion participating in the Event with full knowledge and understanding of such risks. I agree to be solely responsible for my own safety and to take every precaution to provide for my own safety while participating in the Event and while present at the Facility;
2. I understand that my name, photograph, voice, testimonial and/or likeness may be copied and distributed through various media, without authorization from, or notice to, me. I consent to and authorize maCares and its affiliates, and all persons or entities acting with the permission or upon the authority of maCares to use my name, voice, testimonial, photograph and likeness in whole or in part, in connection with merchandising, exhibition, promotion, distribution, sales, broadcast and any and all other commercial or noncommercial purpose or activity relating to maCares whatsoever. This right includes, without limitation, the right to incorporate and use my name, voice, testimonial, photograph and likeness in video, audio, print, photographs, catalogs, packaging, advertisements, magazines, brochures, blogs, social networking, web sites, commercials, broadcasts and in all other forms and media (the “**Materials**”) to reproduce, exhibit, broadcast, transmit, share, sell, assign, license and/or distribute the Materials. I understand that the Materials (and all intellectual property rights associated therewith) are the sole and exclusive property of maCares;
3. I do hereby fully and forever waive, release, discharge and covenant not to sue maCares, First Baptist Church of Jamestown, and/or each of their respective successors, assigns, owners, employees, representatives, officers, agents, directors, coordinators, employees and volunteers (each a “**Releasee**”) from any and all liability, actions, causes of action, suits, proceedings, damages, judgments, executions, claims, and demands whatsoever, in law, equity or otherwise, that may arise in any way in connection with the Event, the Materials or with my presence at the Facility. I intend this Waiver and Release of Liability to be effective whether or not any accident, loss, damage, injury or death results from the negligent, intentional or unintentional acts or omissions to act of one of more of the Releasees. I further agree that if, despite this Waiver and Release of Liability, I, or anyone on my behalf makes a claim or claims against one or more Releasees, I will indemnify and hold such Releasees harmless from any and all litigation expenses, attorney fees, claims, judgments, losses, liability, damages and costs which may be incurred by such Releasees as a result of and/or in association with such claim or claims;
4. This Waiver and Release of Liability shall be governed by the laws of the State of North Carolina, without regard to conflict of law provisions. All actions or proceedings arising out of or relating to this Waiver and Release of Liability shall be instituted and litigated in Greensboro, Guilford County, NC, and I hereby submit to the jurisdiction of such courts;
5. I have received a copy of, read, understood and also agree to abide by the maCares Paws for a Cause Craft Festival Guidelines. If I am signing on behalf of any entity, I represent and warrant that I have the full and complete authority to bind the company. I have read and understand this Agreement and have signed it voluntarily.
